# 9. Presentation

a. Same Day Dial-a-Ride Survey Results

Mr. Capelle started the presentation by stating Laketran received 371 responses to the Same Day Dial-a-Ride survey. The majority of respondents use Laketran for medical appointments and they can no longer drive themselves. Respondents shared Laketran is more reliable then asking friends and family for a ride. Because of this 44% of respondents are unable to take trips if same day transportation is needed. According to survey results, 90% of respondents would use the same day service if it were available even with a slight fare increase. About more than half of the respondents are able to use a mobile app to schedule a ride. With this information, Mr. Capelle and his staff can move to the next step in phase I which is to present a budget in January.
