#### 7. Public Comments

Mr. Massie is again asking the Laketran Board of Trustees to rescind the one quarter of one percent sales tax after learning the property re-evaluation will increase Lake County property taxes by thirty percent in 2024.

Lake County Commissioner, Mr. Hamercheck asked the Laketran Board of Trustees to pass a resolution at the earliest practical opportunity to implement the use of the Ohio Checkbook in the interest of good governance and transparency. Mr. Hamercheck also asked for a resolution at the earliest time possible to suspend the 0.25 percent sales tax and spend down surplus funds with an annual review of Laketran's funding needs.

#### 10. Discussion

#### a. Cash Balance

Mr. Capelle reviewed Laketran's cash balance with the board and provided an overview of the federal COVID dollars received between 2020-2021 that led to larger total cash balance. He presented three solutions to spend down the funds. The first would be to cut one quarter of one percent of the sales tax for one year. The second proposal would be to partner with Lake Development Authority to fill the funding gap for the Fairport Harbor Transient Mariana project and the third proposal would be to fund a sidewalk grant program for Lake County communities.

b. Additional Service

Mr. Capelle outlined a projected budget for Same Day Dial-a-Ride including revenue from fares, start up software costs and annual expenses to operate the new service with a possible launch in

Fall 2024. He estimates it will take three years to fully understand the impact of the additional service.
