Mr. Capelle presented a sidewalk grant program concept including an application process, eligibility, and scoring criteria. Main concepts include sidewalks must be along a bus routes and improve safety and rider experience. Municipalities (grantees) would be responsible for design, right-ofway/easements and maintenance. Local municipalities could apply to Laketran for 100% of the funding, including design. Laketran would reimburse communities based on pre-approval milestones. The Board would like Mr. Capelle to meet with different municipalities to get feedback and a list of bus stops that currently have safety issues.
